



### Pharmacovigilance Summary Report: April-June 2019


The Pharmacy and Poisons Board is the Drug Regulatory Authority established under the Pharmacy and Poisons Act, Chapter 244 of the Laws of Kenya. The Board regulates the Practice of Pharmacy and the manufacture and trade in drugs and poisons.


PPB has 6 directorates of which the Directorate of Medicines Information and Pharmacovigilance (MIPV) is responsible for Pharmacovigilance, Post-Market Surveillance, Clinical Trials & Medicines Information activities. MIPV shares quarterly pharmacovigilance reports with stakeholders to serve as a feedback mechanism and also encourage all stakeholders to report.

Since the introduction of PV in Kenya, a total of 12,231 individual case safety reports has been submitted to the global data reports 20,322,506 (0.06%). This quarter four of 2018/2019, number of reporting went up (831 reports) compared to previous quarter which submitted (104 reports). This could be explained by the fact that vigiflow system was undergoing maintenance for some period and therefore reports could not be uploaded at the time. This are therefore backlog reports for the entire year.




Most ADRs reported consistently by other pharmacists throughout the quarter, followed by other professionals then physician.







Majority of the patients that were affected by ADRs were adults 86% (717 reports) throughout the quarter.





In quarter 4 of 2018/19, 151 (18%) serious ADR reports were reported. Of these, 26 cases were life-threatening and 40 cases required hospitalization. 3 deaths were reported due to suspected ADR and 7 cases were disabling to the patient.






# ADR by sex Unknown 13 Male 333 Female 485

# System organ mostly affected by ADRs is the skin and subcutaneous tissue, followed by nervous system, general disorders and psychiatric in that order.

Outcome of most of the ADRs were unknown 322 (38%), 462(55%) of the total ADRs reported either recovered/resolved or were either recovering or resolving.






This is a measure of how complete an ADR report is filled as assessed by UMC. Quarter 4 had an average completeness score of 77%.

To put this in context, there are over 9,000 health facilities listed in the Kenya Master Facility List (MFL). Top reporting facility in the country is MTRH in Uasin Gishu county.

Most reported ADR terms were either dizziness, rash, headache, drug ineffective, gynecomastia and pruritis among others.



sADR reports were received from 33 of the 47 counties. Nairobi county submitted the highest number of ADRS reports 160 followed by Kisumu 49 reports, Migori 47, Siaya 44 and Kiambu who submitted 38 reports.
