Brief description of the problem

The Pharmacy and Poisons Board has mandated Dawa Life Sciences to initiate an urgent recall of Normnil (Albendazole 400mg) batches; 2103104, 2012082, 2007067, 2007098, 2006202, and 2006200. The product is being recalled following several market complaints on molding, cracking, and change in color. Quality control analysis confirmed discrepancies were observed in the coloration of the tablets, deviating from registered specifications.

Action for healthcare professionals

You are advised to immediately quarantine and stop supplying the remaining stock of impacted batches of the product. Dawa Life Sciences will contact healthcare professionals directly to arrange the return of the products.

Action for patients and carers

Patients who have been prescribed the impacted batches of Normnil (Albendazole 400mg) should seek advice from their healthcare providers. This is because you require a review with your prescribing healthcare professional to discuss alternative treatment options.
