### Brief description of the problem

Following routine Risk-Based Post-Market surveillance activities, the Pharmacy and Poisons Board detected that the above stated batches failed to comply with the specifications on appearance test whereby crystals were observed in the suspension.

### Action for healthcare professionals

Quarantine all remaining stock and stop further distribution, sale, issuing or use of the above batches immediately. Await contact from Dawa Ltd to arrange the return.

### Action for patients and caregivers

No further action is required by patients as this is a Retail/hospital Pharmacy and Wholesaler/Distributor level recall. You are advised to talk to your healthcare professional if you have the above batches of Curamol Suspension.
